THE COMPENSATION OF NEW HIRES IS DETERMINED BY THE HUMAN RESOURCES COMMITTEE AND FINANCE COMMITTEE AND IS IN ACCORDANCE WITH APPROVED BUDGET AMOUNTS. THE BOARD OF DIRECTORS USES COMPARABILITY DATA TO DETERMINE SALARIES, INCLUDING BUT NOT LIMITED TO SALARY STUDY DATA PROVIDED BY THE SOUTH CAROLINA ASSOCIATION OF NONPROFITS, COMPENSATION AMOUNTS PAID FOR SIMILAR POSITIONS AT SIMILAR ONCOLOGY CAMPS AND ORGANIZATIONS IN THE U.S. THE BOARD OF DIRECTORS CONSIDERS THE EDUCATION LEVEL, YEARS OF EXPERIENCE, AND INDIVIDUAL SKILL SET OF EACH EMPLOYEE TO DETERMINE THE AMOUNT OF COMPENSATION.
